We are excited to offer a clinic opportunity with Shane Ledyard, licensed judge for USEF, IHSA, and IEA. Based at his Bucks County farm, Ledyard Equestrian, Shane has made his living as a judge, trainer, competitor, and coach for the past 30 years. His clinics instruct the rider and the horse from his perspective, adding the judge's perspective as well. He also specializes in helping riders who are anxious when they compete improve their riding in ways that will help them build their confidence. Riders, parents, and trainers are encouraged to bring their questions about horse showing and scoring!

Clinic section numbers will be kept small (5/6 riders) to allow everyone to have a good experience. We will offer sessions for the following: Flat work (w/t/c), Cross rails (max 18"), 2', and 2'6". We will offer multiple sessions at each height as needed. There is ample space for auditors and riders waiting for their slots to watch. Please bring your own chairs! Coffee, water, and some light snacks will be provided. Participants are responsible for their own lunch.

The cost of the clinic is as follows:

Early entry discount: Riders \$100.00 Auditors \$20.00

After February 25: Riders \$120.00 Auditors \$25.00
